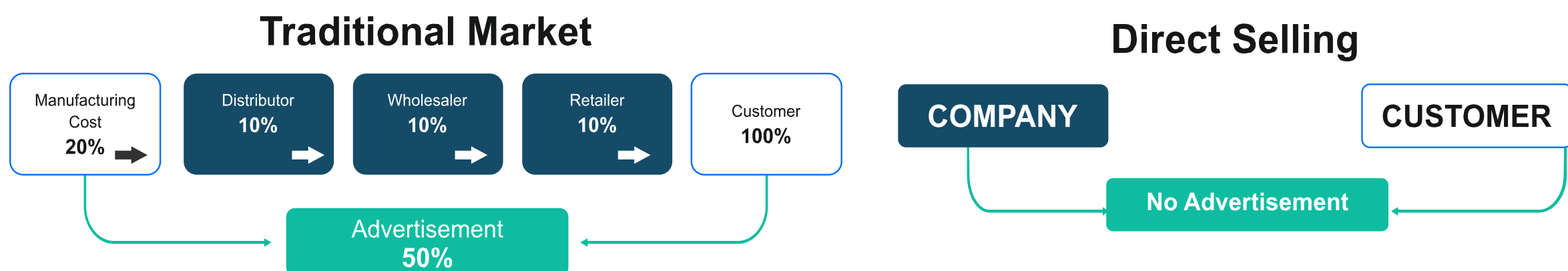


## What is Direct Selling?

You can understand the meaning of the word itself. Direct selling means delivering products directly to customers. In this, all the work is done by a distributor because he markets the product and delivers it directly to the customers. 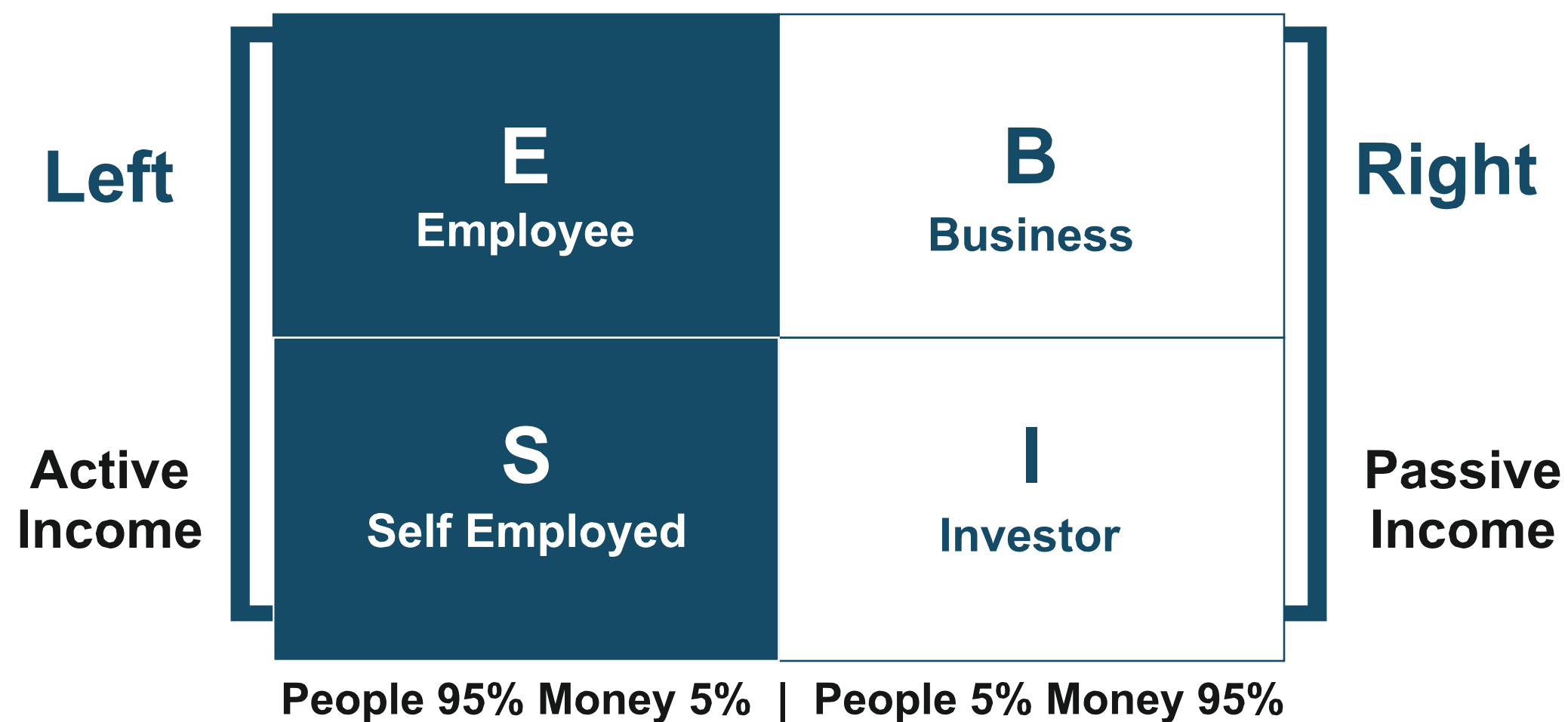
# Ways to earn money

The Cashflow Quadrant is a simple model created by Robert Kiyosaki. It explains that there are four ways to earn money.

You can see all four in the picture below. All these are written in short as ESBI.



Friends, you must have seen that some people earn a lot. Whereas some people always remain poor. It happens because some people run after jobs while others start their businesses. Some people become very rich without much education, whereas very educated people work for such people.

- E means **employee** – People in this quadrant earn money by doing jobs.
- S means **self-employed** – These people are freelancers or self-employed, like doctors, lawyers, CAs. and so on.
- B means for **Business** – People of this quadrant have their own business.
- I mean **Investor** – These people are investors and invest money differently. Due to this, their money keeps growing automatically.

The author says that in these four quadrants, some people earn a lot of money; the rest do not earn that much money, like the left quadrants (E and S) earn less. People in the right quadrant earn more money.

**Active Income and Passive Income:-** Active Income is income in which you get money as long as you remain active. If you are not active, then you will stop getting money. Whereas passive income is a way of earning money in which you keep getting money even if you are not active at some point. Friends, the people in the **Left quadrant** get active income, while those in the **Right quadrant** get passive income. Therefore, we should move from **Left to Right**.
